Gene Mulligan came to the ~~board~~ board with his land proposal for lion hall. A \$60,000 price for 10 acres. Gene will have first option to rent what is not being used. There is some gravel on this land. There will be a 5 year lease. \$150.00 per acre for rent was suggested.

Bernard Budin moved to have Edith Nelson and Richard Moore attend the closing on Oct. 15, 2007 at office of John Ophaug. Robert went to second. Will get a time and set it up. Approved.
