The Greenvale Town Board met Aug 17, 2010 at 7:00 pm at the town Hall with all members present.

The meeting was called to order by Robert Winter, Chairman and the pledge was said.

Minutes from July were read by the clerk. Richard Moore moved to accept and Greg Lange second. Approved.

A representative from Eureka township came before the board to present a plan for ~~receiving~~ tires by the County.

The drop off place will ~~be~~ be by the old town hall site on Cedar & Galapic. Nakata Co. ~~has~~ has a grant for this. Persons bringing will need to have a drivers license to prove residence in Nakata County. This is going to be set for Oct 2 from 8AM-3pm. Need help to check ID's.

A representative from Valley Pools & Spas came to get a permit for a pool for Dell Sand (Verge place). Need Bob Hegner to check plans & then will write permit. Richard Moore moved to accept Greg Lange second. Approved.

De Layne Christensen came with some Ag Bureau papers. He had them filled out for Here County so have to be redone. Joe Kaderka also had questions on Ag Bureau. When he has papers done he will come back.

Scatt Norbunas road in question was next on agenda. People in attendance were - Scatt & LeAnn Norbunas, atty Hirstendahl Craig Braun, atty Jones, atty Nord atty Ophaug. Question of  $\frac{1}{4}$  mile or  $\frac{1}{2}$  mile. needs to be decided. Discussion. Bob Winter moved to do  $\frac{1}{2}$  mile Richard Moore second, Vote - 2-1 Greg Langer was in favor of  $\frac{1}{4}$  mile, Because of cost to residents.  $\frac{1}{2}$  mile passed. The maintenance will be 1 grade in spring 1 grade in fall. some gravel. No snowplowing. Minimum maintenance road status. It will be a dead end road but not private. Atty John Ophaug will do resolutions to finalize this. Will be done at September meeting.

A discussion on attorneys fees were discussed. Scatt & LeAnn Norbunas were supposed to pay lawshier attorneys. As there

was to be no cost to township to resolve this issue. Because of the extent of facts of finding & issues it got lengthy. It was said the township could hold up resolution until fee was paid. A discussion to each pay own fees.

Richard Moore moved to adjust this to read  $\frac{1}{2}$  mile road, 14 ft top, no survey needed, no repayment of cost. Robert Wentw 'second' Approved

Richard Moore asked to have John Ophang to prepare resolution & Township sign at September meeting. Bob Wentw second. All parties agreed.

Ottis reported that culvert on Sarutt Avenue was done.

Deputy abser came & the concern is the break-ins in area & surrounding areas. Houses mostly.

Shoulder reclaiming on roads was discussed. Ottis will be renting a piece of equipment to do this. Have Dale Kuchinka mow once more & then do this will do some of the roads

to try & get results. Some neighboring townships are doing this.

Spraying was discussed & Board decided to do this when crops are done as it looks like an early harvest. After trees were trimmed it was suggested to spray brush to stop regrowth. Will put matter in paper.

Some roads are getting washouts on edges because of the 3" rains we have had. May have to put rocks in there.
